May kindly see the online 01.07.2020 received from Sri Surendra Singh-II, Addl. District and Sessions Judge, Aligarh regarding submission of statements of movable and immovable properties for the financial years 2018-19 and 2019-20 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 and 2019-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2018-19, his gross income from salary and other sources is Rs. 26,27,972/- (Rs. 25,84,472/- from salary and Rs. 43,500/- from S.B. interest) and total deductions/Savings/investments against GPF, GIS, income tax and PLI is Rs. 13,06,913/- ( including enhancement of balance of Rs. 2,79,956/- in his saving bank A.cs against the balance of the previous year). Thus a sum of Rs.13,21,059/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2018-19.
2. In the financial year 2019-20, his gross income from salary and other sources is Rs. 24,05,271/- (Rs.23,47,771/- from salary and Rs. 57,500/- from S.B. Interest) and total deductions/Savings/investments against GPF, GIS, income tax and PLI is Rs. 14,18,848/- (including enhancement of balance of Rs. 4,53,762/- in his saving bank A.cs against the balance of the previous year.) Thus a sum of Rs. 9,86,423/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2019-20.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2017-18 which has already been seen by Hon'ble Mr. Justice Rajesh Dayal Khare, the then Administrative Judge, Aligarh in the in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2018-19 and 2019-20 have been submitted by the Officer vide his online case id no. 1190 dated 01.07.2020 which was due to be submitted upto the end of the financial year 2020-21. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2018-19 and 2019-20 of Sri Surendra Singh-II, Addl. District

and Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
