May kindly see the online request dated 06.07.2020 received from Smt. Rekha Singh, Addl. District and Sessions Judge, Hathras regarding submission of statements of movable and immovable properties for the financial years 2016-17 and 2017-18 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 and 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

1. In the financial year 2016-17, her gross income from salary, and other sources is Rs. 18,37,129/- (Rs. 15,42,883/- from salary, Rs. 28,500/- from Agriculture, Rs. 96,000/- House Rent and Rs. 1,69,746/- from S.B. Interest) and total deductions/Savings/investments against NPS, GIS, IT, PPF, NSC, and LIC is Rs.12,27,550/- (including enhancement of balance of Rs. 2,91,603/- in her saving bank A.cs against the balance of the previous year). Thus a sum of Rs.6,09,579/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2016-17.
2. In the financial year 2017-18, her gross income from salary and other sources is Rs. 15,53,672/- (Rs. 12,23,933/- from salary and Rs. 25,300/- from agriculture, Rs. 96,000/- from House Rent and Rs, 2,08,439/- from SB interest) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, and LIC is Rs.11,57,973/- (including enhancement of balance of Rs. 7,01,044/- in her saving bank A.cs against the balance of the previous year). Thus a sum of Rs.3,95,699/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2017-18.

It is pertinent to mention that the husband of the officer, Sr. Vijay Kumar, is an RTO whose annual income is Rs. 22,29,855/- (F.Y. 2016-17) and Rs. 15,70,106/- (F.Y. 2017-18).

In this connection it is submitted that the officer has already submitted her property statements upto the financial year 2015-16 which have already been seen by Hon'ble Mr. Justice Vivek Chaudhary, the then Administrative Judge, Hathras in the miscellaneous file of the Officer.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 has been submitted by the Officer vide her online case id no. 1214 dated 06.07.2020 which is due to be submitted upto the end of

the financial year 2018-19 as per two year block policy. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2016-17 and 2017-18 of Smt. Rekha Singh, Addl. District and Sessions Judge, Hathras be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Hathras Judgeship for His Lordship's kind perusal and orders ?
