May kindly see the property statement submitted online dated 18.08.2020 received from Sri Brijendra Kumar Pandey, Additional Principal Judge, Family Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income (both the financial years) is Rs.60,95,039/- (including Gross income of Rs.45,33,491/-, matured amount of LIC policy is Rs.13,780/-, matured amount of FD is Rs.5,29,651/-, matured amount of NSC is Rs.1,64,068/-, redemption of equity funds is Rs.8,06,579/- and ITR of RS.47,470/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, PPF a/c, Income Tax, Home Ioan, NSC, FD, SIP of equity funds, Gold Bond, LIC policies, Sukanya Samriddhi Yojna and the balance of his savings bank account(s) is enhanced for Rs.10,29,213/-, total of which is Rs.45,42,481/-. Thus, a sum of Rs.15,52,558/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife is Legal Advisor having monthly salary of Rs.25,000/- and has also a rental income of Rs.29,000/- per month.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Budaun in the misc. file of the officer. It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 18.08.2020. As such, there is no delay in submitting the same.
