May kindly see the property statement submitted online dated 22.07.2020 received from Smt. Twishi Srivastava, Deputy Director, Institute of Judicial Training & Research, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court. In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2015-16 & 2016-17, Gross salary (both the financial years) are Rs.14,49,310/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Car loan and PPF a/c are Rs.6,06,830/-. Thus, a sum of Rs.8,42,480/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.57,784/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted her property statements at the time of entering into judicial service are currently processed online & a separate note has been made on case-id no.1291.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. She has submitted movable and immovable property statements of the financial years 2015-16 & 2016-17 vide online dated 22.07.2020. As such, there is delay in submitting the same from the part of the office.
