May kindly see the online 04.08.2020 received from Sri Pankaj Kumar, Addl. Civil Judge (Sr. Div.), Bareilly regarding submission of statements of movable and immovable properties for the financial years 2017-18 and 2018-19 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-18 and 2018-19 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

- 1. In the financial year 2017-18, his gross income from salary is Rs. 9,95,042/- and total deductions/Savings/investments against NPS, GIS, Income Tax, Tax relief fund, LIC and PPF is Rs. 3,24,613/-. Thus a sum of Rs.6,70,429/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18. The balance of Rs. 31,184/- has decreased from his saving bank A/cs against the balance of the previous year.
- 2. In the financial year 2018-19, his gross income from salary is Rs. 13,81,200/- and total deductions/Savings/investments against NPS, GIS, Income Tax, LIC, FD and PPF is Rs.5,22,238/-. Thus a sum of Rs.8,58,962/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-19. The balance of Rs. 74,216/- has decreased from his saving bank A/cs against the balance of the previous year.

It is submitted that the officer has already submitted his property statements held at the time of entering U.P. Judicial Services which has already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Allahabad in the Misc. file of the officer.

For the preceding financial years, the officer has submitted his property statements for the financial years 2015-16 and 2016-17 which have been processed presently online and separate office note has already been submitted for orders on separate case id no. 819

The movable and immovable property statement for the financial years 2017-18 and 2018-19 have been submitted by the Officer vide his online case id no. 1348 dated 04.08.2020 which was due to be submitted upto the end of the financial year 2019-20. As such, there is delay in submitting the property statements from the part of the officer.
