May kindly see the property statement submitted online dated 07.10.2020 received from Sri Rajeev Kumar Paliwal, Additional District & Sessions Judge, Meerut regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.51,89,460/- (income from salary with arrears is Rs.41,48,695/-, Income from Agriculture is Rs.6,46,000/-, matured amount of insurance policies, FD and KVP & NSC are Rs.2,19,100/-, Rs.32,153/- and Rs.1,43,512/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, PPF a/c, Income Tax, paid for purchase of Activa Scooter, Insurance policies, Mutual funds and the balance of his savings bank account(s) is enhanced for Rs.55,006/-, total of which is Rs.23,42,864/-. Thus, a sum of Rs.28.46,596/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife earns Rs.3,18,000/- & Rs.3,23,000/- form Agriculture in the financial year 2018-19 & 2019-20 respectively and also having annual income from Advocacy of Rs.41,700/- & Rs.42,500/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge, Meerut in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 20.08.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Sri Rajeev Kumar Paliwal, Additional District & Sessions Judge, Meerut be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Meerut for His Lordship's kind perusal and orders?
