May kindly see the property statements submitted online dated 07.08.2020 received from Sri Jai Prakash Singh-II, Principal Secretary(Law) & L.R., Govt. of U.P., Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, total income (both the financial years) is Rs.60,65,421/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, LIC policies, Home loan, medical expenditure, Health Insurance premium and the balance of his savings bank account(s) is also enhanced for Rs.9,81,359/- this financial year from previous year's balance, total of which is Rs.32,36,981/-. Thus, a sum of Rs.28,28,440/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that his wife earns income of Rs.40,000/- to Rs.50,000/- per month from Agriculture and his son is Advocate having monthly income of Rs.50,000/-.

In this connection it is submitted that the officer has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice D.K.Arora, the then Administrative Judge, Mathura in the misc. file of the officer. Anf of the financial years 2016-17 & 2017-18 has processed online & a separate note has been made on case-id no.1439.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 vide online dated 07.08.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Jai Prakash Singh-II, Principal Secretary(Law) & L.R., Govt. of U.P., Lucknow be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
