May kindly see the property statement submitted online dated 22.10.2020 received from Sri Rajiv Maheshwaram, Additional Director (Admin.), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, income from salary is Rs.28,98,057/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, Home loans, LIC, PPF A/C, Sukanya Samriddhi Yojna, SIP and the balance of his savings bank account(s) is enhanced for Rs.62,413/- this financial year from previous year's balance, total of which is Rs.14,92,960/-. Thus, a sum of Rs.14,05,097/- was therefore available with him to meet out the household expenditure of his family consisting six members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement up to the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Vikram Nath, the then Administrative Judge, Lucknow in the misc. file of the officer. And the property statement of the financial years 2014-15 & 2015-16 has been processed & a separate note has been made on eservice Id no.1325.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 up to March 2019. He has submitted movable and immovable property statements for the financial years 2016-17 & 2017-18 firstly vide online dated 02.09.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that-

"He was engrossed in the preparation for the LCDE Exam and was also called for different professional duties to the Hon'ble High Court, JTRI and the UPSLSA. Over and above the cause of delay mentioned above, I unconditionally

accepting my responsibility and latches on my part submit by sincere apologies with the request to kindly condone the delay. I may be further permitted to submit that henceforth, I shall to the best of my capabilities will make most sincere efforts to adhere to the prescribed time period for submission of my property statements."

(As mentioned in the remark column no.9 of the same).

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Sri Rajiv Maheshwaram, Additional Director (Admin.), Lucknow be laid before Hon'ble Mr. Justice Vivek Agarwal, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
