May kindly see the property statement submitted online dated 20.10.2020 received from Sri Suresh Kumar Gupta, Additional District & Sessions Judge (POCSO), Mau regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, total income from salary is Rs.37,20,786/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Car loan, LIC policies, Insurance polcies, PPF a/c, wife's PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.9,222/- this financial year from previous year's balance, total of which is Rs.15,08,246/-. Thus, a sum of Rs.22,12,540/- was therefore available with him to meet out the household expenditure of his family consisting seven members in both the financial years.

It is pertinent to mention here that his wife earns annual income of Rs.90,000/- and Rs.1,20,000/- in the financial years 2018-19 & 2019-20 from sewing, agriculture & other work.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into judicial service which had already been seen by Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Mau in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements

of the financial years 2018-19 & 2019-20 firstly vide online dated 17.08.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Sri Suresh Kumar Gupta, Additional District & Sessions Judge (POCSO), Mau be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders?
