May kindly see the property statement submitted online dated 20.08.2020 received from Sri Sudhakar Rai, Additional District & Sessions Judge, Ramabai Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, Total Gross income (both the financial years) is Rs.63,05,436/- (including annual net income of Rs.46,21,436/-, Agricultural income of Rs.2,00,000/-, interests of Rs.84,000/- & return Rs.14,00,000/- from Ansal API due to cancelled the allotment of flat) and total deductions/ repayment/ savings/ investment (for both the financial years) against PRAN, wife's PRAN, GIS, LIC, PPF a/cs, Income Tax, SIP, Mutual Fund and the balance of his savings bank account(s) is enhanced for Rs.7,45,888/-, total of which is Rs.48,44,168/-. Thus, a sum of Rs.14,61,268/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice B.Amit Sthalekar, the then Administrative Judge, Varanasi in the misc. file of the officer and of the financial years 2016-17 & 2017-18 has been processed & a separate note has been made on e-service ID no.1354.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements

of the financial years 2018-19 & 2019-20 vide online dated 20.08.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Sri Sudhakar Rai, Additional District & Sessions Judge, Ramabai Nagar be laid before Hon'ble Mrs. Justice Sunita Agarwal, Administrative Judge, Ramabai Nagar for Her Lordship's kind perusal and orders?
