May kindly see the property statements submitted online dated 02.10.2019 received from Sri Krishna Kumar-VI, Special Judge (Prev. Cor. Act), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19, income from salary is Rs.21,28,894/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, PLI, Insurance policies, PPF, Mutual funds, Sukanya Samriddhi Yojna, Personal loan and the balance of his savings bank account(s) enhanced for Rs.1,42,551/- this financial year from previous year's balance, total of which is Rs.10,79,514/-. Thus, a sum of Rs.10,49,380/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year.

In this connection it is submitted that Sri Krishna Kumar-VI has already submitted his property statement upto the financial year 2009-10 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Sanjay Misra, the then Administrative Judge, Mau at flag 'Z' in the misc. file of the officer. For the preceding financial years, he has submitted his property statements of the financial years 2010-11 to 2016-17 which have been processed & office note has already been submitted for order in the Misc. file of the officer. And property statement of the financial year 2017-18 has been processed presently online on separate case-id no 120.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year

2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto march 2021. He has submitted property statements for the financial year 2018-19 vide online dated 02.10.2019 (at flag 'A'), As such, there is no delay in submitting the aforesaid property statement from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 of Sri Krishna Kumar-VI, Special Judge (Prev. Cor. Act), Lucknow be laid before Hon'ble Mr. Justice Bala Krishna Narayana, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
