

**Registrar(J)(Budget)**

May kindly see the property statements submitted online dated 11.09.2020 received from Sri Gajendra, Additional District & Sessions Judge, Kasganj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, total income (both the financial years) is Rs.43,41,740/- and total deductions/ repayment/ savings/ investment (for both the financial years) against CPF, GIS, Income Tax, PLI, Insurance policies, PPF a/cs, Mutual fund, Sukanya Samridhi Yojna, Atal Pension Yojna and the balance of his savings bank account(s) is enhanced for Rs.66,226/- this financial year from previous year's balance, total of which is Rs.25,73,452/-. Thus, a sum of Rs.17,68,288/- was therefore available with him to meet out the household expenditure of his family consisting six members in both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that his annual income from Agriculture is about Rs.70,000/- and his mother's agricultural annual income below Rs.70,000/-.

In this connection it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Hardoi in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated

11.09.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Gajendra, Additional District & Sessions Judge, Kasganj be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Kasganj Judgeship for His Lordship's kind perusal and orders?
