May kindly see the property statement submitted online dated 24.08.2020 received from Sri Nalin Kumar Srivastava, District & Sessions Judge, Meerut regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Gross income from salary & other sources (both the financial years) is Rs.54,85,883/-and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, PPF a/c, Income Tax, Insurance policies, Car loan and the balance of his savings bank account(s) is enhanced for Rs.8,40,888/-, total of which is Rs.34,94,642/-. Thus, a sum of Rs.19,91,241/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife earns annual income of Rs.2.5 Lac & 4 Lac through Music classes in the financial years 2018-19 & 2019-20 respectively. His elder son is advocate having annual income about Rs.3 Lac & Rs.8 Lac in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice P.K.S.Baghel, the then Administrative Judge, Ghaziabad in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March

2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 24.08.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Sri Nalin Kumar Srivastava, District & Sessions Judge, Meerut be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Meerut for His Lordship's kind perusal and orders?
