May kindly see the property statement submitted online dated 26.08.2020 received from Sri Kamal Deep, Chief Judicial Magistrate, Sambhal regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 & 2018-19, income from salary & other sources (of both the financial years) are Rs.31,69,295/- (including two transfer bills of Rs.99,063/- & 30% arrear of 7th pay commission of Rs.3,38,049/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, Personal loan, LIC, Health policy, Home loan and the balance of his savings bank account(s) is enhanced for Rs.2,90,284/- this financial year from previous year's balance, total of which is Rs.16,08,800/-. Thus, a sum of Rs.15,60,495/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2014-15 which had already been seen by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Azamgarh in the misc. file of the officer. And of the financial years 2015-16 & 2016-17, a separate note has been made on case-id no.1444.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated

26.08.2020. As such, there is delay in submitting the same from the part of the officer for which he has regretted in his letter dated 07.09.2019 (attached 'covering letter' with the statement)

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Kamal Deep, Chief Judicial Magistrate, Sambhal be laid before Hon'ble Mr. Justice Devendra Kumar Upadhyaya, Administrative Judge, Sambhal Judgeship for His Lordship's kind perusal and orders?
