May kindly see the property statement submitted online dated 08.10.2020 received from Sri Vijay Kumar-II, Additional District & Sessions Judge, Meerut regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.55,22,657/- (income from gross salary including allowances, arrear of Interim relief Pay Commission, arrear ACP, LLM increment & EL encashment of Rs. 53,42,657/- and house rent of Rs.1,80,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, PPF a/c, Income Tax, Home loan, Sukanya Samriddhi yojna, LIC policies and the balance of his savings bank account(s) is enhanced for Rs.14,00,250/-, total of which is Rs.38,14,143/-. Thus, a sum of Rs.17,08,514/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife earns Rs.1,53,128/- & Rs.1,75,000/- from private teaching & others in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge, Meerut in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements

of the financial years 2018-19 & 2019-20 vide online dated 08.10.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Sri Vijay Kumar-II, Additional District & Sessions Judge, Meerut be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Meerut for His Lordship's kind perusal and orders?
