May kindly see the online 04.09.2020 received from Sri Sudhir Kumar-III, Presiding Officer, Motor Accident Claim Tribunal, Ghaziabad regarding submission of statements of movable and immovable properties for the financial years 2018-19 and 2019-20 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 and 2019-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

- 1. In the financial year 2018-19, his gross income from salary and other sources is Rs. 29,90,873/- (Rs. 28,45,549/- from, Rs. 21,432/- from Honorarium, Rs. 1,23,272/- from S.B. Interest and Rs. 620/- from IT Return) and total deductions/Savings/investments against GPF,GIS, Income Tax, PPF, RD, LIC and Loan-repayment is Rs. 13,66,691/-. Thus a sum of Rs.16,24,182/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-19. The balance of Rs. 41,907/- has decreased from his saving bank A/c against the balance of the previous year.
- 2. In the financial year 2019-20, his gross income from salary and other sources is Rs. 27,98,858/- (Rs.26,57,463/- from salary, Rs. 21,432/- from Honorarium, Rs. 7,440/- from IT Return and Rs. 1,12,523/- from S.B interest) and total deductions/Savings/investments against GPF,GIS, FD, Income Tax, PPF, RD, LIC and Loan-repayment is Rs. 22,73,869/-. Thus a sum of Rs. 5,24,989/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2019-20. The balance of Rs.3,25,545/- has decreased from his saving bank A/c against the balance of the previous year.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2017-18 which has already been seen by Hon'ble the then Chief Justice, Allahabad High Court in the in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2018-19 and 2019-20 have been submitted by the Officer vide his online case id no. 1479 dated 04.09.2020 which is due to be submitted upto the end of the financial year 2020-21. As such, there is no delay in submitting the property statements from the part of the officer.
