May kindly see the property statement submitted online dated 07.10.2020 received from Sri Chandra Vijay Srinet, Additional District & Sessions Judge, Hardoi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, Total income from salary (both the financial years) is Rs.25,76,523/- (including interests) and total deductions/ repayment/ savings/ investment against GPF/CPF, GIS, Income Tax, PPF, LIC, RD and mutual fund are Rs.13,93,622/-. Thus, a sum of Rs.11,82,901/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.7,54,152/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into judicial service and of the financial years 2006-07 to 2013-14 has already been submitted before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Hardoi for kind perusal and orders on the detailed office note dated 19.12.2020, in the misc. file of the officer. And of the financial years 2014-15 & 2015-16 are currently processed & separate note has made on case-id no.1394.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 up to March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated

07.10.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that he could not submit the property statement in time due to busy in work, missing of some pass book, & some personal problems. So, he regret for this & seek apology to Hon'ble High Court and requested to accept his apology for delay mentioned in the remark column no.9.

May, therefore, if approved, property statements of the financial years 2016-17 & 2017-18 of Sri Chandra Vijay Srinet, Additional District & Sessions Judge, Hardoi be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Hardoi Judgeship for His Lordship's kind perusal and orders?
