May kindly see the property statement submitted online dated 28.09.2020 received from Sri Vineet Chaudhary, Additional District & Sessions Judge, Gautam Budh Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 & 2017-18, Total income is Rs.37,32,107/- (Income from salary+H.R.R. are Rs.31,98,202/-, Agricultural income of Rs.80,000/-, Mandey Sec. DLSA of Rs.1,669/-, interest of SB a/c of Rs.92,303/- & received matured amount of NSC of Rs.3,59,933/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, House rent paid to landlord, LIC policies, PPF a/c & NSC are Rs.16,98,038/- and the balance of his savings bank account(s) is enhanced for Rs.10,59,886/- this financial year from previous year's balance, total of which is Rs.27,57,924/-. Thus, a sum of Rs.9,74,183/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2015-16 which has already been seen online by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Gautam Budh Nagar.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 up to March 2019. He has submitted movable and immovable property statements for the financial years 2016-17 & 2017-18 vide online dated

28.09.2020. As such, there is delay in submitting the same from the part of the officer for which no explanation has been submitted by the officer.

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Sri Vineet Chaudhary, Additional District & Sessions Judge, Gautam Budh Nagar be laid before Hon'ble Mr. Justice Ramesh Sinha, Administrative Judge, Gautam Budh Nagar Judgeship for His Lordship's kind perusal and orders?
