May kindly see the property statement submitted online dated 23.09.2020 received from Sri Manoj Kumar Tiwari, Additional District & Sessions Judge/F.T.C., Lalitpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 & 2018-19, Total income is Rs.31,94,235/- (income from salary is Rs.31,39,081/- & redeem amount of mutual fund is Rs.55,154/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF a/c, loan, Insurance policies, Sukanya Samridhi Yojna and the balance of his savings bank account(s) is enhanced for Rs.1,82,492/- in this financial year from previous year's balance, total of which is Rs.18,10,619/-. Thus, a sum of Rs.13,83,616/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife is a private teacher having monthly income of Rs.10,000/- per month.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2014-15 which had already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Allahabad in the misc. file of the officer and of the financial years 2015-16 & 2016-17 are currently processed online & a separate note has been made on case-id no.1533.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years

2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 26.06.2020 in incorrect block . As such, there is delay in submitting the same from the part of the officer for which he has stated with utmost respect & humbleness, he beg forgiveness and sincere apologies before Hon'ble Court in his letter dated 23.09.2020.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Manoj Kumar Tiwari, Additional District & Sessions Judge/F.T.C., Lalitpur be laid before Hon'ble Mr. Justice Arvind Kumar Mishra-I, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders?
