May kindly see the property statement submitted online dated 28.09.2020 received from Sri Vineet Chaudhary, Additional District & Sessions Judge, Gautam Budh Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, Total income is Rs.46,57,728/- (Income from salary+H.R.R.+Medical reimbursement are Rs.43,96,308/-, Agricultural income of Rs.80,000/-, interest of SB a/c of Rs.1,39,802/- & received matured amount of NSC of Rs.41,618/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, House rent paid to landlord, LIC policies, PPF A/C & SBI life policy are Rs.23,20,473/- and the balance of his savings bank account(s) is enhanced for Rs.6,47,251/- this financial year from previous year's balance, total of which is Rs.29,67,724/-. Thus, a sum of Rs.16,90,004/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection it is submitted that officer has already submitted his property statement up to the financial year 2015-16 which has already been seen online by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Gautam Budh Nagar and of the financial years 2016-17 & 2017-18 has submitted online before Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Gautam Budh Nagar for kind perusal & order on e-service ID no.1495.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years

2018-19 & 2019-20 in its next financial year i.e., 2020-21 up to March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 vide online dated 28.09.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Vineet Chaudhary, Additional District & Sessions Judge, Gautam Budh Nagar be laid before Hon'ble Mr. Justice Ramesh Sinha, Administrative Judge, Gautam Budh Nagar Judgeship for His Lordship's kind perusal and orders?
