<u>Joint Registrar(J)(Budget)</u>

May kindly see the property statement submitted online dated 09.11.2020 received from Sri Rajendra Prasad Tripathi, Additional District & Sessions Judge (POCSO), Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, total income is Rs.36,55,933/- (income from salary is Rs.33,36,412/- and income from house rent & interest from S.B.A/cs & capital gain are Rs.3,19,521/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, shares, Car Ioan, LIP, Home Ioan and the balance of his savings bank account(s) is enhanced for Rs.62,700/- this financial year from previous year's balance, total of which is Rs.14,46,409/-. Thus, a sum of Rs.22,09,524/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2015-16, which had already been seen by Hon'ble Mr. Justice D.S.Tripathi, the then Administrative Judge, Deoria in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 up to March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 firstly vide offline dated 11.10.2017 in the misc. file of the officer & 2017-18 vide online dated 09.11.2020. As such, there is delay in submitting the property statement of the

financial year 2017-18 for which no explanation has been submitted by the officer concerned.

May, therefore, if approved, property statements of the financial year 2016-17 & 2017-18 of Sri Rajendra Prasad Tripathi, Additional District & Sessions Judge (POCSO), Varanasi be laid before Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
