May kindly see the property statement submitted online dated 08.10.2020 received from Sri Yajnesh Chandra Pandey, Additional District & Sessions Judge/F.T.C., Mirzapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2015-16 & 2016-17, income from salary is Rs.22,20,357/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, LIC policies, PPF and the balance of his savings bank account(s) is enhanced for Rs.4,02,486/- this financial year from previous year's balance, total of which is Rs.11,79,333/-. Thus, a sum of Rs.10,41,024/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife is Area Rationing Officer (PCS-2010 batch) having annual income of Rs.5,81,349/- & Rs.4,17,502/- in the financial years 2015-16 & 2016-17 respectively.

In this connection, it is submitted that the officer has submitted his property statement upto the financial year 2012-13, which has already been seen by Hon'ble Mr. Justice Tarun Agarwala, the then Administrative Judge, Varanasi in the mlsc. file of the officer and of the financial years 2013-14 & 2014-15, a separate note has been made on case-id no.1580.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements

of the financial years 2015-16 & 2016-17 vide online dated 08.10.2020. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2015-16 & 2016-17 of Sri Yajnesh Chandra Pandey, Additional District & Sessions Judge/F.T.C., Mirzapur be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Mirzapur Judgeship for His Lordship's kind perusal and orders?
