May kindly see the property statement submitted online dated 08.10.2020 received from Sri Pradeep Kumar-IV, Additional District & Sessions Judge/ F.T.C., Rampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 & 2018-19, Total gross income is Rs.31,95,640/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, LIC policies, Mutual fund, PPF a/c, FD and NSC are Rs.26,29,038/-. Thus, a sum of Rs.5,66,602/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.1,18,359/- in this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2012-13 which had already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge, Lakhimpur Kheri in the misc. file of the officer and of the financial years 2013-14 to 2016-17, a note has already been submitted before Hon'ble Mr. Justice Alok Singh, Administrative Judge, Rampur for kind perusal & orders (in the misc. file of the officer).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online in the

year,2019 in e-service ID no. 302 & 303. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Pradeep Kumar-IV, Additional District & Sessions Judge/ F.T.C., Rampur be laid before Hon'ble Mr. Justice Alok singh, Administrative Judge, Rampur Judgeship for His Lordship's kind perusal and orders?
