May kindly see the property statements submitted online dated 13.10.2020 received from Smt. Sapna Tripathi, Secretary, District Legal Services Authority, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2016-17 & 2017-18, Total income is Rs.34,98,352/- (Gross income from salary is Rs.30,97,737/- and matured amount of Insurance policies are Rs.4,00,615/-) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, Car loan, PPF a/c, Insurance policies, Sukanya Samriddhi Yojna, NPS and the balance of her savings bank account(s) is enhanced for Rs.2,88,217/- this financial year from previous year's balance, total of which is Rs.19,80,943/-. Thus, a sum of Rs.15,17,409/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband is Manager in NTPC having annual income of Rs.20,36,954/- & Rs.26,83,198/- in the financial years 2016-17 & 2017-18 respectively.

In this connection it is submitted that officer has already submitted her property statement upto the financial year 2015-16, which has already seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Bulandshahar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property

statements for the financial years 2016-17 firstly offline letter dated 11.04.2018 in the misc. file of the officer & 2017-18 firstly vide online dated 28.09.2020 on e-service ID no. 919. As such, there is delay in submitting the property statement of the financial year 2017-18 from the part of the officer.

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Smt. Sapna Tripathi, Secretary, District Legal Services Authority, Lucknow be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
