May kindly see the property statement submitted online dated 13.10.2020 received from Smt. Sapna Tripathi, Secretary, District Legal Services Authority Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-19 & 2019-20, Total Income is Rs.49,56,326/- (income from salary is Rs.47,44,035/- and matured amount of Tanishq Golden Harvest Scheme is Rs.2,12,291/-) and total deductions/ repayment/ savings/ investments (for both the financial years) against GPF, GIS, Income Tax, Car loan, PPF a/c, Insurance policies, Sukanya Samriddhi Yojna and Tanishq Golden Harvest Scheme are Rs.32,89,274/-. Thus, a sum of Rs.16,67,052/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.3,41,671/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is Deputy General Manager in NTPC having annual income of Rs.43,66,331/- & Rs.33,97,572/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that officer has already submitted her property statement upto the financial year 2015-16, which has already seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Bulandshahar in the Misc. file of the officer. and of the financial years 2016-17 & 2017-18, a separate note has been made on e-service Id no.1651.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 13.10.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Smt. Sapna Tripathi, Secretary, District Legal Services Authority, Lucknow be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
