

**Joint Registrar(J)(Budget)**

May kindly see the property statement submitted online dated 12.03.2021 received from Sri Pushkar Upadhyay, Special Judge (Pre. Cor. Act), Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, total income from salary & arrears are Rs.34,87,646/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, Home Loan, LIC policies and PPF a/c are Rs.22,49,211/-. Thus, a sum of Rs.12,38,435/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.1,05,181/- this financial year from previous year's balance.

In this connection, it is submitted that hat the officer has already submitted his property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Sunil Ambwani, the then Administrative Judge, Kanpur Nagar in the misc. file of the officer. And of the financial years 2010-11 to 2013-14, a detailed office note be laid before Hon'ble Mr. Justice Arvind Kumar Mishra-I, Administrative Judge, Jhansi for kind perusal & orders, in the misc. file of the officer. And of the financial years 2014-15 & 2015-16 are currently processed & separate online note has made on case-id no.1704.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 up to March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 17.12.2020. As such, there is delay in submitting the property statements of the aforesaid financial years for which he has stated that "the applicant could not submit the above said statements well in time due to long illness of his mother and then her death, severe illness of elder brother and then his death and due to transfer in the April,2015 from Jhansi to Varanasi. He tenders unconditional apology for the delay." (mentioned in attachment dated 06.12.2020).

May, therefore, if approved, property statements of the financial years 2016-17 & 2017-18 of Sri Pushkar Upadhyay, Special Judge (Pre. Cor. Act), Varanasi be laid before Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
