May kindly see the property statements submitted online dated 02.01.2021 received from Sri Pradeep Kumar Singh-II, Principal Judge, Family Court, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-19 & 2019-20, Total income from salary is Rs.56,81,046/- (including income from salary, arrears & other allowances of Rs.50,12,993/-, NSC of Rs.1,01,881/-, received amount as Policy surrender is Rs.5,30,571/- & received amount as surrender of bonds is Rs.35,601/-) and total deductions/ repayment/ savings/ investments against GIS, CPF, Income Tax, Car loan, Child Care policy in both the financial years and the balance of his savings bank account(s) is enhanced for Rs.17,15,691/- this financial year from previous year's balance, total of which is Rs.32,44,014/-. Thus, a sum of Rs.24,37,032/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement up to the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Shri Narayan Shukla, the then Administrative Judge, Lucknow in the misc. file of the officer and of the financial years 2016-17 & 2017-18 has been recently submitted before Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Varanasi for kind perusal and orders with the detailed office note, submitted online on case Id no.1942.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year

2018-19 & 2019-20 in its next financial year i.e., 2020-21 up to March 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 vide online dated 02.01.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Pradeep Kumar Singh-II, Principal Judge, Family Court, Varanasi be laid before Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
