May kindly see the online request dated 20.10.2019 received from Sri Avinash Chandra Gautam, Addl. Civil Judge (Jr. Div.), Faizabad regarding submission of statements of movable and immovable properties for the financial year 2017-18 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2017-18 , his gross income from salary and other sources is Rs.8,32,659/- (Rs. 8,22,000/- from Salary and Rs. 10,659/- from other sources) and total deductions/Savings/investments against GIS, Income Tax, PPF, LIC, U/s -10 and U/s 80C & 80TTA is Rs.5,18,288/-. Thus a sum of Rs.3,14,371/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18. The balance of Rs. 1,09,089/- from his saving bank a/ cs has decreased against the balance of the previous year.

It is pertinent to mention here that the Officer's wife, Smt. Tanya Singh, is self employed (Home tuition) whose annual income is Rs. 2,00,000/-, Sri Rajendra Prasad, (Father) is a pensioner whose annual income is Rs.6,72,,000/- and Smt. Savitri Devi,(mother) whose annual income is Rs. 2,80,000/-(Agricultural and other sources).

In this connection, it is also submitted, the property statement held at the time of entering Judicial Service and for the financial year 2016-17 have been submitted by the officer vide case id no.195, but the he has not shown his details of deduction from salary, salary, saving bank account balance as on 31.03.2017 so an objection has been submitted dated 15.11.2019.

The movable and immovable property statement for the financial year 2017-18 has been submitted by the Officer vide his online case id no. 196 dated 20.10.2019 which was due to be submitted upto the end of the financial year 2018-19 as per two year block policy. As such, there is delay in submitting the property statements from the part of the officer, he has apologized for the delay caused.

May, if approved, the movable and immovable property statements for the financial year 2017-18 of Sri Avinash Chandra Gautam, Addl. Civil Judge (Jr. Div.), Faizabad be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Faizabad Judgeship for His Lordship's kind perusal and orders?
