May kindly see the property statement submitted online dated 25.01.2021 received from Sri Nitish Kumar Rai, Registrar (J) (Admin.), High Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 & 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2012-13 & 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2012-13 & 2013-14, total income from salary & rental income are Rs.21,81,166/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Home loan, LIC policies, Bonds and PPF a/cs are Rs.12,79,055/-. Thus, a sum of Rs.9,02,111/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.2,588/- this financial year from previous year's balance.

It is pertinent to mention here that his wife earns around Rs.12,000 - Rs.15,000/- monthly from tuitions.

In this connection, it is submitted that the officer has already submitted his property statement up to the financial years 2011-12 which had already been seen by Hon'ble Mr. Justice Arun Tandon, the then Administrative Judge, Lucknow in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2012-13 & 2013-14 in its next financial year i.e., 2014-15 up to March 2015. He has submitted movable and immovable property statements of the financial years 2012-13 & 2013-14 vide online dated 25.01.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated in his reply dated 10.03.2021 that- "Due to rush of work and illness of my father I failed to submit my property statement in time for the financial year 2012-14. I undertake to be prompt and punctual in future. So it is kindly requested to condone the delay for the submission of property statement . I shall be highly obliged. "

Here, it is also submitted that as per resolution dated 12.07.2013 of Hon'ble the Administrative Committee, the matter is likely to be submitted before Hon'ble The Chief Justice, as the officer is presently posted at High Court, Lucknow Bench, Lucknow..

May, therefore, if approved, property statements of the financial years 2012-13 & 2013-14 (2012-14) of Sri Nitish Kumar Rai, Registrar (J) (Admin.), High Court, Lucknow be laid before Hon'ble The Chief Justice for His Lordship's kind perusal and orders?
