May kindly see the online request dated 20.10.2019 received from Sri Avinash Chandra Gautam, Addl. Civil Judge (Jr. Div.), Faizabad regarding submission of statements of movable and immovable properties for the financial year 2018-19 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2018-19 , his gross income from salary and other sources is Rs.11,15,172/- (Rs. 11,05,416/- from Salary and Rs. 9,756/- from other sources) and total deductions/Savings/investments against GIS, loan, Income Tax, LIC, U/s -10 and U/s 80C & 80TTA, standard deduction and Kerala Relief fund is Rs.6,32,413/- (including enhancement of Rs. 1,35,378/- in his saving bank a/cs against the balance of the previous year. Thus a sum of Rs.4,82,759/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-19.

It is pertinent to mention here that the Officer's wife, Smt. Tanya Singh, is self employed (Home tuition) whose annual income is Rs. 2,00,000/-, Sri Rajendra Prasad, (Father) is a pensioner whose annual income is Rs.6,72,,000/- and Smt. Savitri Devi,(mother) whose annual income is Rs. 28,000/-(Agricultural and other sources).

In this connection, it is submitted that for the preceding financial year, he has submitted his property statements held at the time of entering Judicial Services, for the financial years 2016-17 and 2017-18 which have been processed presently online and separate office notes have already been submitted for orders on separate application id no. 344, 195 and 196

The movable and immovable property statement for the financial year 2018-19 has been submitted by the Officer vide his online case id no. 197 dated 20.10.2019 which was due to be submitted upto the end of the financial year 2020-21 as per two year block policy. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial year 2018-19 of Sri Avinash Chandra Gautam, Addl. Civil Judge (Jr. Div.), Faizabad be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Faizabad Judgeship for His Lordship's kind perusal and orders?
