May kindly see the property statement submitted online dated 18.02.2021 received from Sri Rakesh, Judge Small Causes Court, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Gross income from salary (of both the financial years) is Rs.27,10,246/- and total deductions/ repayment/ savings/ investment against GIS, PPF, LIC, Sukanya Samridhi Yojna, Income Tax, NPS, Mutual fund, Car loan and the balance of his savings bank account(s) is enhanced for Rs.61,166/- this financial year from previous year's balance, total of which is Rs.9,36,664/-. Thus, a sum of Rs.17,73,582/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection it is submitted that the officer has already submitted his property statement of the financial year 2014-15 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Varanasi at flag 'Z' with the order issued to the officer is advised to submit the property statements timely and accurately. And of the financial years 2015-16 & 2016-17 has already been submitted before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Varanasi for kind perusal & orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements

of the financial years 2017-18 & 2018-19 vide online dated 18.02.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that the delay submission of the statements due to Covid'19 and requested to accept the same (mentioned in remark column of the movable).

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Rakesh, Judge Small Causes Court, Varanasi be laid before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
