

**Joint Registrar(B)(Judicial)**

May kindly see the property statement submitted online dated 29.10.2019 received from Sri Arvind Kumar Srivastava, Additional District & Sessions Judge, Rampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2016-17, income from salary is Rs.19,99,819/- (including Rs.1,80,000/-Per year as House rent, Rs.50,400/- received as interest from M.I.S. 2 accounts and Income of Intrest of S.B. A/C/ F.D./ F.D. MOD A/C/ N.S.C./ K.V.P is Rs.87,367/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, LIC, Insurance policy, PPF a/c, Mutual funds and the balance of his savings bank account(s) is enhanced for Rs.80,999/- this financial year from previous year's balance, total of which is Rs.16,82,230/-. Thus, a sum of Rs.3,17,589/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

In this connection, it is submitted that Sri Arvind Kumar Srivastava has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge, Meerut in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements

for the financial years 2016-17 vide online dated 29.10.2019. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2016-17 of Sri Arvind Kumar Srivastava, Additional District & Sessions Judge, Rampur be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Rampur Judgeship for His Lordship's kind perusal and orders?
