May kindly see the property statement submitted online dated 05.11.2019 received from Sri Santosh Kumar-III, Special Judge (SC/ST, Pev. Of Atroci Act), Mahoba regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17, income from salary is Rs.15,67,141/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Car Ioan, Home Ioan, LIC & PPF a/c are Rs.6,44,309/-. Thus, a sum of Rs.9,22,832/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year. And the balance of his savings bank account(s) is also reduced for Rs.2,06,676/- this financial year from previous year's balance.

In this connection it is submitted that for the preceding year, he has submitted his property statement upto the financial year 2015-16, which has already seen by Hon'ble Mr. Justice Akhilesh Chandra Sharma, the then Administrative Judge, Mahoba in the Misc. file of the officer with the warning issued to the officer to remain careful in future to submit the property statement on time.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial year 2017-18 vide online dated 05.11.2019. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2016-17 of Sri Santosh Kumar-III, Special Judge (SC/ST, Pev. Of Atroci Act), Mahoba be laid before Hon'ble Mrs. Justice Sunita Agarwal, Administrative Judge, Mahoba Judgeship for Her Lordship's kind perusal and orders?
