May kindly see the property statement submitted online dated 06.11.2019 received from Sri Gagan Kumar Bharti, Additional District & Sessions Judge, Sitapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18, income from salary is Rs.16,33,634/- and total deductions/ repayment/ savings/ investment against GIS, CPF, Income Tax, PPF a/c, LIC policies, Home Loan, SBI Pension Plan, Medical Health Plan, SBI life Insurance policy, mutual funds and the balance of his savings bank account(s) is enhanced for Rs.2,14,995/- this financial year from previous year's balance, total of which is Rs.12,23,545/-. Thus, a sum of Rs.4,10,089/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

It is pertinent to mention here that his wife is working as Associate Advocate having annua Income of Rs. 5,88,418/-.

In this connection it is submitted that Sri Gagan Kumar Bharti has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Sitapur in the misc. file of the officer. And property statement of the financial year 2016-17 has been processed presently online and on separate case-id no 249.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements

for the financial years 2016-17 vide online dated 06.11.2019. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2017-18 of Sri Gagan Kumar Bharti, Additional District & Sessions Judge, Sitapur be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Sitapur Judgeship for His Lordship's kind perusal and orders?
