## <u>Joint Registrar (J)(Budget)</u>

May kindly see the online request dated 07.11.2019 received from Sri Raj Mani, Special Judge (SC/ST, Prev. Of Atroci. Act), Balrampur regarding submission of statements of movable and immovable properties for the financial year 2015-16 proforma to this Court for kind perusal and information as required by the Court.

Earlier the officer has submitted his movable and immovable property statements for the calendar years 1999, 2000, 2001, 2002 and 2003 and for the financial years 2004-05 to 2013-14. The Office note was submitted before Hon'ble Administrative Judge, Ballia for kind perusal and orders the file was received back with verbal order and direction to ask the officer to submit his movable and immovable property statements for the financial years 2014-15, 2015-16, 2016-17 and 2017-18. So a Court's letter dated 20.08.2019 was sent to the officer to submit his movable and immovable property statements for the financial years 2014-15, 2015-16, 2016-17 and 2017-18. In compliance to this letter, the officer has submitted his movable and immovable property statements for the financial years 2014-15, 2015-16, 2016-17 and 2017-18 in online mode vide application id no. 234, 270, 257 and 258.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-16 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2015-16, his gross income from salary is Rs.16,30,457/- and total deductions/Savings/investments against GPF, GIS, Income Tax, LIC, Loan- repayment and PPF is Rs. 9,60,194/-. Thus a sum of Rs.6,70,263/- was therefore available with him to meet out the household expenditure of his family consisting of six members in the financial year 2015-16. The Balance of Rs. 61,489/- from his saving bank a/c has decreased against the balance of the previous year.

It is pertinent to mention here that the Officer's son, Sri Rajesh Kumar is a Deputy Jailer whose monthly income is Rs. 37,000/-.

In this connection, it is submitted that for the preceding years, he has submitted his property statements for the calendar years 1999, 2000, 2001, 2002 and 2003 and for the financial years 2004-05 to 2013-14 which have been processed presently offline and an Office note has been submitted before Hon'ble Mr. Justice Devendra Kumar Upadhyaya, Administrative Judge, Balrampur Judgeship for kind perusal and orders on dated 22.11.2019 and he has submitted his movable and immovable property statement for the financial year 2014-15 in online mode vide application id

no. 234, which has been processed online and separate office note has been submitted for orders.

The movable and immovable property statement for the financial year 2015-16 has been submitted by the Officer vide his online case id no. 270 dated .07.11.2019 which was due to be submitted upto the end of the financial year 2016-17 as per two year block policy. As such, there is delay in submitting the property statements from the part of the officer and he has apologised for the delay caused.

May, if approved, the movable and immovable property statements for the financial year 2015-16 of Sri Raj Mani, Special Judge (SC/ST, Prev. Of Atroci. Act), Balrampur be laid before Hon'ble Mr. Justice Devendra Kumar Upadhyaya, Administrative Judge, Balrampur Judgeship for His Lordship's kind perusal and orders?
