May kindly see the property statement submitted online dated 04.03.2020 received from Sri Shiva Nand Gupta, Additional Chief Judicial Magistrate, Sitapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17, income from salary is Rs.7,92,503/- and total deductions/ repayment/ savings/ investment against GIS, CPF, Income Tax, Car loan, Life insurance plan, Mutual funds and the balance of his savings bank account(s) is enhanced for Rs.15,414/- this financial year from previous year's balance, total of which is Rs.3,87,776/-. Thus, a sum of Rs.4,04,727/- was therefore available with him to meet out the household expenditure of his family consisting two members in whole of the financial year.

In this connection it is submitted that for the preceding year, he has submitted his property statement at the time of joining into judicial service, which has already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Pratapgarh in the mlsc. file of the officer and of the financial year 2013-14, 2014-15 & 2015-16, separate notes has been made on case-id no.4, 25 & 26 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements for the financial year 2016-17 vide online dated 30.09.2019. As such, there is delay in submitting the same from the part of the officer for which he has regretted for late submission of the aforesaid property

statements and in future, this mistake will not repeat in his attached letter (with the statement of 2013-14) dated 28.09.2019.

May, therefore, if approved, property statements for the financial year 2016-17 of Sri Shiva Nand Gupta, Additional Chief Judicial Magistrate, Sitapur be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Sitapur Judgeship for His Lordship's kind perusal and orders?
