May kindly see the property statement submitted online dated 07.08.2020 received from Sri Gyanender Singh Yadav, Additional District & Sessions Judge, Shamli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18, income from salary is Rs.9,98,231/- (including Rs.50,000/- from agriculture) and total deductions/ repayment/ savings/ investment against GIS, PRAN, Income Tax, Insurance policies, Home loan, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.46,128/- this financial year from previous year's balance, total of which is Rs.7,57,007/-. Thus, a sum of Rs.2,41,224/- was therefore available with him to meet out the household expenditure of his family consisting three members in whole of the financial year.

It is pertinent to mention here that his wife also earns Rs. 1,00,000/- to Rs.1,50,000/- approx per annum from Agricultural Land obtained her parental side and she is an Income tax payee.

In this connection it is submitted that he has already submitted his property statement upto the financial year 2009-10 (in the misc. file of the officer), which has been seen by Hon'ble Mr. Justice Rajesh Dayal Khare, the then Administrative Judge, Rampur. And for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15, 2015-16 & 2016-17 which has been processed presently online and separate office notes has already been submitted for order on e-service id no. 275, 276, 277, 278, 279, 280 & 281 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years

2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial year 2017-18 firstly vide online dated 11.11.2019. As such, there is delay in submitting the same from the part of the officer for which no explanation has been submitted by the officer.

May, therefore, if approved, property statements of the financial year 2017-18 of Sri Gyanender Singh Yadav, Additional District & Sessions Judge, Shamli be laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Shamli Judgeship for His Lordship's kind perusal and orders?
