

**Joint Registrar(B)(Judicial)**

May kindly see the property statement submitted online dated 13.11.2019 received from Sri Nasir Ahmad-III, Principal Judge, Family Court, Mainpuri regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18, income from salary is Rs.17,40,664/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.5,80,353/- this financial year from previous year's balance, total of which is Rs.10,40,839/-. Thus, a sum of Rs.6,99,825/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

In this connection it is submitted that for the preceding year, he has submitted his property statement upto the financial year 2015-16, which has been processed presently online & separate office note has already been submitted for order on separate case-id no 310 and an objection has been made on the property statement of the financial year 2016-17 (case-id no.311).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial year 2017-18 vide online dated 13.11.2019. As such, there is delay in submitting the same from the part of the officer for which he has stated that (attached the letter with the property statement of the financial year 2017-18), due to busy in the judicial

work, the submission of property statement is delayed and request the Hon'ble Court to condone the delay & accept the same.

May, therefore, if approved, property statements for the financial year 2017-18 of Sri Nasir Ahmad-III, Principal Judge, Family Court, Mainpuri be laid before Hon'ble Mr. Justice Anil Kumar, Administrative Judge, Mainpuri Judgeship for His Lordship's kind perusal and orders?
