May kindly see the property statements submitted online dated 09.09.2019 received from Smt. Shabina Khan, Civil Judge (Jr. Div.), Kushinagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

- (1) In the financial year 2016-17 (i.e., from 11.01.2017 to 31.03.2017), income from salary is Rs.5,29,996/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax & the balance of her savings bank account(s) is enhanced for Rs.72,404/- this financial year from previous year's balance, total of which is Rs.99,164/-. Thus, a sum of Rs.4,30,832/- was therefore available with her to meet out the household expenditure of herself in about three months of the financial year.
- (2) In the financial year 2017-18, income from salary is Rs.7,90,838/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax and NPS are Rs.93,752/-. Thus, a sum of Rs.6,97,086/- was therefore available with her to meet out the household expenditure of her family consisting of two members in whole of the financial year. And the balance of her savings bank account(s) is also reduced for Rs.96,267/- this financial year from previous year's balance.

It is pertinent to mention here that her husband's annual income of Rs.61000/-monthly as Civil Judge.

In this connection it is submitted that for the preceding year, she has submitted her property statement at the time of entering into U.P. Judicial service, which has already seen by Hon'ble Mr. Justice Ram surat Ram (Maurya), the then Administrative Judge, Kushinagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements for the financial year 2016-17 & 2017-18 vide online dated 09.09.2019. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Smt. Shabina Khan, Civil Judge (Jr. Div.), Kushinagar be laid before Hon'ble Mr.
