May kindly see the online request dated 15.11.2019 received from Sri Abhinav Tiwari, Civil Judge (Jr. Div.), Faizabad regarding submission of statements of movable and immovable properties for the financial year 2017-18 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2017-18 , his gross income from salary is Rs.8,23,206/- and total deductions/Savings/investments against GIS, Income Tax, PPF, LIC and Recurring deposit is Rs.2,25,117/-. Thus a sum of Rs.5,98,089/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18. The balance of Rs. 34,016/- from his saving bank a/cs has decreased against the balance of the previous year.

It is pertinent to mention here that the Officer's wife, Smt. Snigdha Tiwari, is self employed whose annual income is Rs. 3,00,000/- , Sri Achchhay Lal Tiwar (Father) is an advocate whose annual income is Rs.8,00,000/- and Smt. Madhu Tiwari (mother) is a Principal whose annual income is Rs. 6,00,000/-.

In this connection, for the preceding financial years, he has submitted his property statements held at the time of entering Judicial Services and for the financial year 2016-17 which have been processed online and separate office notes have already been submitted for orders on separate case id no. 298 and 320.

The movable and immovable property statement for the financial year 2017-18 has been submitted by the Officer vide his online case id no. 322 dated 15.11.2019 which was due to be submitted upto the end of the financial year 2018-19 as per two year block policy. As such, there is delay in submitting the property

statements from the part of the officer, he has apologized for the delay caused.

May, if approved, the movable and immovable property statements for the financial year 2017-18 of Sri Abhinav Tiwari, Civil Judge (Jr. Div.), Faizabad be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Faizabad Judgeship for His Lordship's kind perusal and orders?
