## Joint Registrar (J)(Budget)

May kindly see the online letter 09.09.2019 received from Sri Deepak Kumar Mishra, Addl. Civil Judge (Sr. Div.), Aligarh regarding submission of statements of movable and immovable properties for the financial year 2017-18 proforma to this Court for kind perusal and information as required by the Court.

Earlier the officer had submitted his movable and immovable property statement for the financial year 2017-18 but he had not shown amount deposited against PPF, SIP and Mutual Fund in the financial year 2017-18. So an objection was raised on 15.11.2019 to mention the aforesaid amount. In reply to this objection the officer has submitted his revised movable and immovable property statements as **an attachment** on 29.11.2019.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2017-18, his gross income from salary and arrears is Rs. 8,74,913/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, SIP and Mutual Fund is Rs.5,56,784/-. Thus a sum of Rs. 3,18,129/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18. The balance of Rs. 1,73,983/- from his saving bank A/cs has decreased against the balance of the previous year. Cash of Rs. 30,000/- in hand has decreased against the cash in hand of the previous year.

In this connection it is submitted that Sri Mishra has already submitted his property statements upto the financial year 2016-17 which has already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Allahabad in the miscellaneous file of the Officer.

The movable and immovable property statement for the financial year 2017-18 have been submitted by the Officer vide his online case id no. 33 dated 09.09.2019 which is due to be submitted upto the end of the financial year 2019-20. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial year 2017-18 of Sri Deepak Kumar Mishra, Addl. Civil Judge (Sr. Div.), Aligarh be laid before Hon'ble Mr. Justice B Amit Sthalekar, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
