May kindly see the property statement submitted online dated 27.02.2020 received from Sri Ramesh Dubey, Additional Principal Judge, Family Court, Jaunpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 & 2017-18, total income is Rs.34,72,553/- (income from salary is Rs.30,56,876/-, interests from savings is Rs.1,48,047/-, matured amount of PPF is Rs.2,09,330/- & maturity bonus of LIC money back policy is Rs.58,300/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, LIP, Income Tax, Tuition Fees, Mutual funds and the balance of his savings bank account(s) is enhanced for Rs.3,31,279/- this financial year from previous year's balance, total of which is Rs.17,87,121/-. Thus, a sum of Rs.16,85,432/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

In this connection, it is submitted that Sri Ramesh Dubey has already submitted his property statement upto the financial year 2015-16, which had already been seen by Hon'ble Mr. Justice Vipin Sinha, the then Administrative Judge, Bareilly in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 27.02.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that the aforesaid

statements was supposed to be send in the financial year 2018-19 but due to some confusion and misunderstanding it was not sent in the specified time, he has recognise his mistake, therefore he heartly apologize for this and requested to accept this statement in the remark column of aforesaid statements.

May, therefore, if approved, property statements of the financial year 2016-17 & 2017-18 of Sri Ramesh Dubey, Additional Principal Judge, Family Court, Jaunpur be laid before Hon'ble Mr. Justice Abhinava Upadhya, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders?
