May kindly see the online application 20.11.2019 received from Smt. Meena Srivastava, Judicial Member, Commercial Tax Tribunal, Gorakhpur regarding submission of statements of movable and immovable properties for the financial year 2015-16 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-16 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

1. In the financial year 2015-16, her gross income from salary and other sources is Rs. 13,59,088/- (Rs. 12,66,465/- from salary, Rs. 92,623/- from bank interest and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, and LICs is Rs. 7,27,107/- (including enhancement of balance of Rs. 24,686/- in her saving bank A/c against the balance of the previous year). Thus a sum of Rs. 6,31,981/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2015-16.

It is pertinent to mention that the husband of the officer, Sri Praful Kamal is an Addl. District and Sessions Judge, UP Judicial Services whose annual income is Rs. 14,23,681/- in the financial year 2015-16.

In this connection it is submitted that Smt. Srivastava has already submitted her property statements upto the financial year 2013-14 which has already been seen by Hon'ble Mr. Justice Tarun Agarwala, the then Administrative Judge, Kanpur Nagar in the personal file of the Officer. For the preceding financial year, she has submitted her property statement for the financial years 2014-15 which has been processed presently online and separate office note has already been submitted for orders on separate case id no. 354.

The movable and immovable property statement for the financial year 2015-16 has been submitted by the Officer vide her online case id no. 355 dated 20.11.2019 which is due to be submitted upto the end of the financial year 2016-17. As such, there is delay in submitting the property statements from the part of the officer. May, if approved, the movable and immovable property statements for the financial year 2015-16 of Smt. Meena Srivastava, Judicial Member, Commercial Tax Tribunal, Gorakhpur be laid before Hon'ble Mr. Justice Ved Prakash Vaish, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders?
