May kindly see the property statement submitted online dated 27.11.2019 received from Sri Mohd. Ashraf Ansari, Spcl. Judge (SC/ST, Pev. of Atroci Act), Meerut regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18, income from salary is Rs.15,43,083/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, LIC, Mutual funds, PPF a/c & the balance of his savings bank account(s) is enhanced for Rs.7,57,965/- this financial year from previous year's balance, total of which is Rs.12,47,535/-. Thus, a sum of Rs.2,95,548/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

In this connection it is submitted that for the preceding year, he has submitted his property statement upto the financial year 2015-16, which has already seen by Hon'ble Mr. Justice Manoj Misra, Administrative Judge, Meerut in the Misc. file of the officer and for the financial year 2016-17, which has been processed on case-id no.401. It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial year 2017-18 vide online dated 27.11.2019. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2017-18 of Sri Sri Mohd. Ashraf Ansari, Spcl. Judge (SC/ST, Pev. of

Atroci Act), Meerut be laid before Hon'ble Mr. Justice Manoj Misra, Administrative Judge, Merrut Judgeship for His Lordship's kind perusal and orders?
