May kindly see the online letter 30.11.2019 received from Sri Ravi Kant, Addl. District and Sessions Judge, Budaun regarding submission of statements of movable and immovable properties for the financial year 2014-15 proforma to this Court for kind perusal and information as required by the Court.

Earlier the officer had submitted his movable and immovable property statement for the financial year on 30.11.2019 but it was found that amount of Rs. 1,84,060/- was left with him to maintain the household expenditure in the financial year 2014-15. So an objection dated 18.12.2019 was raised to get his clarification how he had managed to maintain his four member family expenditure in the financial year 2014-15 with a meager amount of Rs. 1,84,060/-. In reply to this objection, the officer again submitted amended details of deductions dated 15.01.2020 and he has stated that he had an amount of Rs. 3,01,760/- in the financial year 2014-15.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-15 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2014-15, his gross income from salary and other sources is Rs. 16,85,331/- (Rs. 12,42,044/- from salary and allowances, Rs. 66,000/- from house rent and Rs. 3,77,287/- from FDRs maturity) and total deductions/Savings /investments against GPF, GIS, Income Tax, PPF, Insurances, RD, SIP, Mutual Fund, loan-repayment, and FD is Rs.13,83,571/- (including enhancement of Rs. 34,948/- in his saving bank A/cs against the balance of the previous year). Thus a sum of Rs. 3,01,760/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.

In this connection it is submitted that Sri Kant has already submitted his property statements upto the financial year 2013-14 which has already been seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Lucknow in the miscellaneous file of the Officer.

The movable and immovable property statement for the financial year 2014-15 have been submitted by the Officer vide his online case id no. 413 dated 30.11.2019 which is due to be submitted upto the end of the financial year 2016-17. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial year 2014-15 of Sri Ravi Kant, Addl. District and Sessions Judge, Budaun be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Budaun Judgeship for His Lordship's kind perusal and orders?
