May kindly see the property statement submitted online dated 30.11.2019 received from Smt. Sonali Poonia, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Ramabai Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2015-16 & 2016-17, income from salary is Rs.15,26,198/- (including interests on FDR of Rs.21,717/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax and PPF are Rs.4,92,584/-. Thus, a sum of Rs.10,33,614/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.1,61,015/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is Judicial Officer having annual income of Rs.3,57,487/- in the financial year 2016-17.

In this connection, it is submitted that the officer has already submitted her property statements at the time of entering into judicial service are currently processed online & a separate note has been made on case-id no.1039.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. She has submitted movable and immovable property statements of the financial years 2015-16 & 2016-17 vide online dated 30.11.2019. As such, there is delay in submitting the same from

the part of the office for which she has stated that due to official duty occupation, and excess of work at work place she could not submit the same earlier and requested to accept her apology for late submission of property statement and gave assurance that this will not be a recurring event in her reply dated 01.06.2020..

May, therefore, if approved, property statements of the financial year 2015-16 & 2016-17 of Smt. Sonali Poonia, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Ramabai Nagar be laid before Hon'ble Mrs. Justice Sunita Agarwal, Administrative Judge, Ramabai Nagar Judgeship for Her Lordship's kind perusal and orders?
