May kindly see the property statement submitted online dated 30.11.2019 received from Smt. Sonali Poonia, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Ramabai Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2017-18 & 2018-19, income from salary is Rs.22,10,620/- (including interests on FDR of Rs.27,286/-)and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, NPS, PPF and the balance of her savings bank account(s) is enhanced for Rs.80,971/- this financial year from previous year's balance, total of which is Rs.8,31,440/-. Thus, a sum of Rs.13,79,180/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years.

It is pertinent to mention here that her husband is Judicial Officer having annual income of Rs.10,55,661/- & Rs.8,47,744/- per annum in the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the officer has already submitted her property statements at the time of entering into judicial service and of the financial years 2015-16 & 2016-17 are currently processed online & separate notes has been made on case-id no.1039 and 416 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property

statements of the financial years 2017-18 & 2018-19 vide online dated 30.11.2019. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Smt. Sonali Poonia, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Ramabai Nagar be laid before Hon'ble Mrs. Justice Sunita Agarwal, Administrative Judge, Ramabai Nagar Judgeship for Her Lordship's kind perusal and orders?
