May kindly see the property statement submitted online dated 09.11.2020 received from Sri Santosh Kumar Tiwari, Additional District & Sessions Judge, Pratapgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 of the officer concern It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial year 2017-18 firstly vide offline dated 03.04.2018 in the misc. file of the officer. As such, there is delay in submitting the same from the part of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19, income from salary is Rs.17,78,443/- (including T.A., D.A., allowances etc.) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, KVP, Kerala relief fund, Insurance policies and loan are Rs.13,63,008/-. Thus, a sum of Rs.11,10,037/- was therefore available with him to meet out the household expenditure of his family consisting two members in whole of the financial year. And the balance of his savings bank account(s) is also reduced for Rs.4,007/- this financial year from previous year's balance.

In this connection it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been seen by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Azamgarh in the misc. file of the officer. And for the financial years 2015-16, 2016-17& 2017-18 which has been processed presently online and separate office notes has already been submitted for order on e-service id no. 398, 412 & 419 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable

and immovable property statement for the financial year 2018-19 firstly vide online dated 17.01.2020. As such, there is no delay in submitting the same from the part of the officer for which no explanation has been submitted by the officer.

May, therefore, if approved, property statements for the financial year 2018-19 of Sri Santosh Kumar Tiwari, Additional District & Sessions Judge, Pratapgarh be laid before Hon'ble Mr. Justice Yashwant Varma, Administrative Judge, Pratapgarh Judgeship for His Lordship's kind perusal and orders?
