May kindly see the property statement submitted online dated 03.12.2019 received from Sri Utkarsh Chaturvedi, Additional District & Sessions Judge, Sultanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18, income from salary is Rs.17,26,621/- (including arrears) and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Car loan and the balance of his savings bank account(s) is enhanced for Rs.49,019/- this financial year from previous year's balance, total of which is Rs.6,12,694/-. Thus, a sum of Rs.11,13,927/- was therefore available with him to meet out the household expenditure of himself in whole of the financial year.

In this connection, it is submitted that Sri Utkarsh Chaturvedi has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Pankaj Mithal, the then Administrative Judge, Meerut in the misc. file of the officer with the warning issued to the officer to be careful in future & not to commit such mistake and of the financial year 2016-17, which is currently processed on case-id no.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-17 vide online dated 03.12.2019. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2017-18 of Sri Utkarsh Chaturvedi, Additional District & Sessions Judge, Sultanpur be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
