

### **Joint Registrar (J)(Budget)**

May kindly see the online letter 04.12.2019 received from Sri Vijay Kumar Verma-I, Addl. District and Sessions Judge, Aligarh regarding submission of statements of movable and immovable properties for the financial years 2016-17 and 2017-18 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 and 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2016-17, his gross income from salary and other sources is Rs.12,38,506/- (Rs.12,04,841/- from salary and Rs.33,665/- from Saving A/c interest) and total deductions/Savings/investments against CPF, GIS, Income Tax, PPF, and LIC is Rs.6,01,468/- (including enhancement of balance of Rs. 95,535/- in his saving bank A/cs against the balance of the previous year). Thus a sum of Rs.6,37,038/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-17.
2. In the financial year 2017-18, his gross income from salary and other sources is Rs.13,15,542/- (Rs.13,05,688/- from salary and Rs.9,854/- from saving A/cs interest) and total deductions/Savings/investments against CPF, GIS, Income Tax, PPF and LIC is Rs.7,58,223/- (including enhancement of balance of Rs. 2,36,029/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs. 5,57,319/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18.

It is pertinent to mention that the wife of the officer, Smt. Jayanti Singh is self employed (Coaching) whose monthly income is Rs. 17,000/- in 2016-17 and Rs. 20,000/- in 2017-18.

In this connection it is submitted that Sri Verma has already submitted his property statements upto the financial year 2015-16 which has already been seen by Hon'ble Mr. Justice Rajesh Dayal Khare, the then Administrative Judge, Aligarh in the miscellaneous file of the Officer.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 have been submitted by the Officer vide his online case id no. 437 dated 04.12.2019 which was due to be submitted upto the end of the financial year 2018-19. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2016-17 and 2017-18 of Sri Vijay Kumar Verma-I, Addl. District and Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice B. Amit Sthalekar, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
